Minutes of 19 March 2021

Meeting was opened at 7:08 PM by Commander Linscott with 5 officers and 2 members present.

Minutes of the 19 February 2021 meeting were read, approved and filed with Post Adjutant

### **Committee Reports**

**Finance Officer** Marston reported that all bills were paid and the Key Bank account had a balance of \$10,545.54 of which \$4,504.33 in General Fund, \$6,041.21 in Savings. Report was made and held for audit.

**Membership Chairman** Splettstoesser reported that 82 of our 86 members have paid their annual dues for a percentage of 105%. Department holds our percentage at 91% based on a goal of 79 members. New method of counting membership has been put in place. We have 4 members who have not renewed to date.

**Executive Committee** Splettstoesser read the minutes of the Executive Committee meeting of 2/26/2021. The New Business from that meeting were items that were tabled at the previous regular meeting and were not acted on because that meeting did not have a quorum and therefore motions could not be acted on. Those four (4) items are as follows:

- 1. Sponsorship of a Little League team and the diversion of funds allotted for American Legion Baseball be allocated to the Little League team in the National League. Motioned by Ed Tyler and seconded by Tony Batchelor Passed. Contact with Richard Matthews to be made by Adjutant
- 2. Donation of \$53.80 to the South Portland Food Bank which was ½ of the total received from the bottle redemption. Motion to make payment from the General Fund by Mike Pock and seconded by Ed Tyler Passed. Adjutant to deliver check.
- 3. "Honorary Life Membership" in the American Legion for 50 year members and WWII members of our Post annually from Post funds. Motion by Ed Tyler and seconded by Tony Batchelor Passed. Adjutant to pay dues and contact members.
- 4. Purchase and Installation of Security Camera for the Post with a cost of not to exceed \$250. Funds to come from Building Fund Account as authorized by Finance Committee member present at this meeting. Motion by Mike Pock and seconded by Ed Tyler Passed. Installation to be done within the next week.

**Trustees Chairman** Pock reported that the Security Camera System has been install with the help of member Ouillette, Seymourian and Kohnke. Final hookup to Internet will be before the next meeting. In addition, while the wiring was being accomplished, the Emergency Light unit on the 1<sup>st</sup> floor was replaced. All material cost was under the allotted amount.

**Americanism Officer** Marston reported that based on information from the latest District meeting that although Oratorical has been cancelled by Department the Boys & Girls State, at this time, is still on schedule.
