Finance Committee – All outstanding bills have been paid for the Fire Damage Project with the exception of \$3,502.62 owed to Pock Carpentry LLC. The balance of \$2,215.08 from Patriot Inc. has been received and deposited in the General Fund account. The payment to Pock Carpentry LLC can now be processed upon approval of Finance Committee.
